A TIMELINE OF FACTS

- 1990s & 2000s** Arrested three times for **drunken driving (DUI)**¹
- 2008** Accused of **“a subterfuge to get around the lobbying prohibition”** by the chairman of the Miami-Dade Ethics Commission²
- 2021** Served as registered agent of Champlain Towers, then stated it was a **“clerical error”**³
- 2021** Sued the **City of Miami Beach** in a failed effort to run for a third term as **City Commissioner**⁴
- 2023** Accepted **\$50,000** contribution from a developer now under FBI investigation⁵
